**PAYMENT OF DUES, FEES AND CHARGES Initial \_\_\_\_\_**

I hereby acknowledge that all dues, fees and charges for food, beverage, merchandise and services at Riverton Country Club (the "Club"), together with any applicable taxes or similar charges that are not paid in cash payments are permitted, will be billed on a monthly basis.

I authorize any and all charges (including all membership dues and fees), incurred on my account with the Club and unpaid within 60 days to be charged to the credit card listed below. I certify that the below listed card is issued to me and agree that all disputes on my credit card account relating to the Club with be promptly brought to the Club's attention. I understand that I am obligated to keep a valid approved credit card or pre-signed, undated check in the amount of my monthly dues and food/beverage minimum on file with the club at all times. I further acknowledge that I am personally responsible for any uncollected fees/expenses incurred by me, my authorized family members, and/or my invited guests. Members must notify the Club upon the expiration date of any credit card on file so we can update our records. This card may also be used to make monthly automatic payments if you wish on or around the 1st day of each month.

**ACCEPTANCE OF PAYMENT TERMS Initial \_\_\_\_\_**

If accepted for membership, I hereby agree to pay to the Club, within one week of acceptance, the full membership initiation/joining fee. Or alternatively, I will execute a contract for financing this deposit with the Club. I further agree to pay membership dues as billed on a monthly basis by the Club. I understand/agree that my/our account shall be due and payable by the end of each month, upon the receipt of the monthly statement. Accounts unpaid 60 days after the billing date are delinquent and the Club may charge a finance fee of 1.75% of the past due balance. Accounts unpaid 90 days after the billing date will be charged the same finance fee of 1.75% plus a \$35.00 late fee. I acknowledge that dues and fees are subject to periodic revision. The amount of dues currently for each membership category is described on the schedule attached to this application. I agree if I do not provide written notice to the "Club" of my intent to cancel my membership by December 15 of membership year, my membership will automatically renew, and I shall be liable for annual membership dues for the next year. I understand the "Clubs" "use it or lose it" policy. I understand that for the months of April through October. I am required to spend a minimum of \$20.00 per month on food and beverage in the Clubhouse. Should I fail to meet the \$20.00 minimum, I will be charged for the balance of the unspent amount. Upon signing this Agreement, the undersigned authorizes the disclosure and release of information to the Club for investigating my qualifications for membership, including my credit history.
